



GENERAL CONTEST RULES

1. **Prizes are not transferable and non-exchangeable.** Flagstaff Radio/Great Circle Media/Southwest Media/Shine Ministries reserves the right to substitute a prize of equal or greater value if the awarded prize is unavailable for any reason
2. Contestants and qualifiers are limited to **winning one prize per household in a 30 day period** unless it is otherwise noted in specific contest rules.
3. Winners of all contests must be an Arizona resident and reside within the broadcast area.
4. Winners must be 18 years of age or older at the time of entry unless another age is specified for a specific contest.
5. Prizewinners have fourteen (14) days from the date your name is first announced on the air, or by other disclosed mode of public dissemination, to claim and pick up their prize. Failure to claim and pick up prize within this time for any reason will result in forfeiture of the prize.
6. Flagstaff Radio/Great Circle Media/Southwest Media/Shine Ministries is not responsible for any cancellation or rescheduling of the performance for any reason and has no obligation to reimburse, refund or otherwise substitute the tickets for another prize should the performance not be rescheduled or vouchers not issued.
7. Great Circle Media/Southwest Media reserves the right, in its sole discretion, to award unclaimed prizes to alternate contestants or not to award the unclaimed prizes.
